## **Protecting Your Privacy**

At Fundi Finance, we take your privacy seriously. This Privacy Policy outlines how we collect, use, and protect your personal information in accordance with the Australian Privacy Act 1988 (Cth).

# Information We Collect and How We Use It

When assisting you with your financial needs, we may collect personal information including your name, contact details, financial information, and any relevant employment details. We may also collect sensitive information, such as health information, if necessary to assess your financial situation responsibly.

We use this information solely for the purposes of:

- Evaluating and processing your financial applications
- Matching you with suitable funding options
- Facilitating communication and managing your relationship with us (e.g., sending invoices, conducting client satisfaction surveys)
- **Providing you with requested financial product information** (unless you opt out of electronic communications)

We will never sell or trade your personal information to third parties.

## **Sharing Your Information**

We may disclose your information only in the following circumstances:

- To our credit provider partners you choose to work with (and their representatives) to process your application.
- To trusted third-party service providers who assist us with specific tasks (e.g., data storage, mailing). We ensure these providers adhere to the Australian Privacy Principles (APPs).
- As required by law or court order, or under other exceptional circumstances permitted by the Privacy Act.

## Security and Retention of Information

We employ robust physical, electronic, and procedural safeguards to protect your information from unauthorized access, use, disclosure, alteration, or destruction. We retain your information only for as long as necessary to fulfill the purposes for which it was collected or comply with relevant laws and regulations.

## Accessing and Updating Your Information

You have the right to access and update your personal information held by Fundi Finance.
